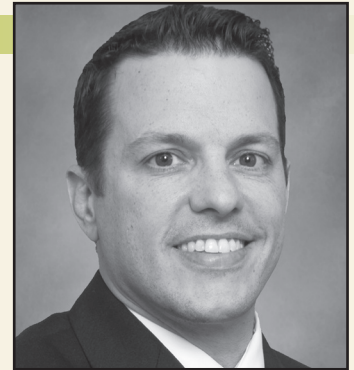
JACK CORRADINO

ALL DEBTS NOT NECESSARILY RESOLVED IN DISCHARGE BY BANKRUPTCY COURT

One purpose of federal bankruptcy laws is to allow people to settle their debts and gain a fresh start. Once debts listed in the bankruptcy documents have been satisfied, (in whole or in part, or not at all if the debtor lacks sufficient assets), the debts may be “discharged” or extinguished by order of the bankruptcy court. There are, however, some debts which the law does not allow to be discharged. Among these are debts that arise out of “willful and malicious injury by the debtor to another entity or the property of another entity.”

Stay of Lawsuits and Motions Regarding Dischargeability of Debts

While a bankruptcy proceeding is in progress, and assuming proper notice has been given, there is an automatic “stay” of some lawsuits against the debtor. In other words, such cases will be put on hold and not allowed to proceed forward until the stay is lifted.

The plaintiff in a pending lawsuit against the debtor may:

1. Apply for “relief” from the stay in order to proceed with an action in that court; and/or
2. May file a “proof of claim” and “adversary proceeding” in the bankruptcy court to determine the case and whether the judgment would be dischargeable.

Following the enactment of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005, the automatic stay has been eliminated in cases involving eviction actions, driver’s license suspensions, child support actions, or divorce proceedings.

If a judgment already exists against the debtor from a prior lawsuit, the judgment creditor may (and probably should) file a proof of claim and “adversary proceeding” with the bankruptcy court to contest discharge of the judgment, if the judgment has been listed in the bankruptcy papers as a debt for which discharge is sought. The burden of proving the debt is nondischargeable by a “preponderance of the evidence” is that of the judgment creditor.



SOME DIETARY SUPPLEMENTS CITED IN FDA HEALTH ADVISORY

Many people take dietary supplements to support their diets with herbs, vitamins and minerals. In some instances, dietary supplements can provide health benefits. In others, the unexpected risks can injure or even kill consumers.

The distribution and marketing of dietary supplements is regulated by the Food and Drug Administration (FDA), which protects consumers by enforcing strict guidelines for food and drug safety and by warning the public not to purchase or consume potentially dangerous products. In order to avoid increased health risks, consumers should independently research the products they use and heed the advice of the FDA.

Dietary Supplements Containing Sildenafil. In December of 2007 the FDA issued a Public Health Advisory, warning consumers against taking certain dietary supplements that were determined to

contain a potentially harmful prescription drug ingredient called sildenafil.

Sildenafil is an active ingredient in the prescription drug Viagra, which is used to treat male erectile dysfunction. An interaction between sildenafil and certain drugs containing nitrates may cause a drastic and potentially life-threatening lowering of blood pressure. The FDA has determined that the following dietary supplements contain sildenafil:

- Super Shangai
- Shangai Ultra
- Lady Shangai
- Strong Testis
- Shangai Ultra X

Other public health warnings have been issued at the state level for herbal dietary supplements that have tested positive for dangerous prescription drugs. Two Chinese herbal medicine products: (1) PC SPES, which tested positive for the prescription drug warfarin, and (2) SPES, which tested positive for the prescription drug alprazolam, were cited in a warning issued in February 2002 by the California State Department of Health Services, for example.
