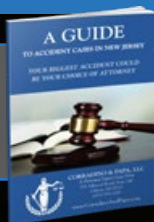

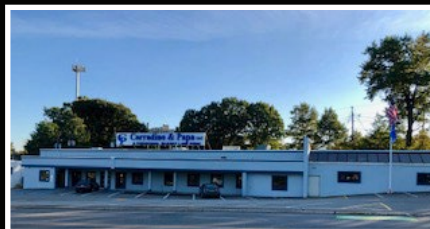

autumn driving

CAN BE CHALLENGING

Cooler temperatures, vivid foliage, and shorter days signal the arrival of autumn, a season that challenges drivers in unique ways.

Fall weather can be unpredictable. In many areas of the country, sun, rain, fog, frost, ice, and snow are all part of the mix. Diminishing daylight equates to more nighttime driving and associated visibility issues. Fallen leaves can obscure traffic markings and hide potholes. Wet leaves can be as slick as ice.

During fall and winter, the sun is naturally lower in the sky than in the spring and summer, creating a lower angle of reflection that leads to blinding glare. Driving can be downright treacherous. The effect is most intense 15-45 minutes after sunrise and before sunset. It can strike from behind, too, reflecting off rear view mirrors and upcoming traffic lights.

Autumn also marks a rise in deer-vehicle incidents. Increased deer activity in the fall is due to breeding season. Males become bolder and less attentive, persistently seeking mates over a wider territory. If the females aren't ready to breed, they'll do whatever they can to get away. Both situations mean an increased frequency of road crossings. Hunting season stirs the pot as well.

If a deer suddenly crosses your path, brake—don't swerve—to maintain control of your car. If you see one deer, be on the lookout for more; they travel in groups.

Reduced speed, awareness of your surroundings, a good pair of sunglasses, and proper vehicle maintenance are excellent safety measures for fall driving, but other drivers need to follow suit. Mexican pumpkin punch

This festive fall punch comes with additional options, including an alcoholic variation.

Ingredients

- 2 cups packed dark brown sugar
- 4 cinnamon sticks
- 1 29-ounce can (or about 3 ½ c.) of pure pumpkin
- 2 limes
- Rum (optional)
- Pineapple chunks and/or pecans (optional)

Preparation

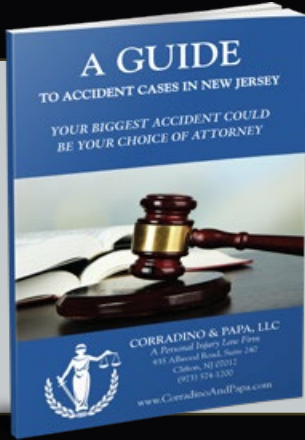
- Add 12 cups water, brown sugar, and cinnamon sticks to a large pot and boil over medium-high heat, stirring until the sugar is dissolved. Stir in the pure pumpkin and return to a simmer.
- Meanwhile, remove the zest from the limes in wide strips with a vegetable peeler. Add to the pot and simmer 15 minutes.
- Let the mixture cool, then refrigerate 2-3 hours. The pumpkin pulp will settle to the bottom.
- Working in batches, ladle the liquid into a fine-mesh strainer set over a pitcher. Discard pumpkin pulp and lime zest. Return the cinnamon sticks to the punch and refrigerate until serving time.
- Pour into ice-filled glasses. Add a splash of rum, pineapple, and/or pecans, if desired. ■

military personnel AND 3M EARPLUGS

In 2016, Moldex-Metric Inc. filed a whistleblower lawsuit on behalf of the U.S. government against 3M (formerly Aearo Technologies, Inc.), manufacturer of the Dual-Ended Combat Arms Earplugs Version 2 (CAEv2) that were used by the military. The suit alleged that 3M failed to disclose defects in the design of their earplugs for over a decade. As such, the government did not seek other protective options, and military personnel suffered resultant hearing damage.

CAEv2 earplugs were designed with a dual purpose: One end would restrict all sound; the other end could be used to restrict high-decibel sound but allow low-level sound to reach the ear to enable continued verbal communication. However, the earplugs were too short to be inserted correctly. They frequently loosened imperceptibly, allowing high-decibel noise to damage the ears.

Military personnel have experienced hearing loss, total hearing loss, and tinnitus. Tinnitus is a condition in which phantom sounds such as ringing, humming, buzzing, etc., interfere with hearing external sounds. These injuries also take an emotional, mental, and financial toll.

3M settled the whistleblower case for \$9.1 million in July 2018 but admitted no liability. 3M was penalized for false advertising and reimbursed the U.S. government for the cost of purchasing their product.

The settlement had no bearing on individuals harmed by CAEv2. Anyone who served in the military between 2003 and 2015, wore these earplugs, and suffered hearing damage might be entitled to compensation. Tens of thousands of military veterans may have been affected. If you are among them, contact a product liability attorney to protect your rights. Don't delay... claim-filing deadlines differ from state to state. ■
